#### 2022 RUNNING ELECTRIC CONTEST RULES

#### 1. RULES OF PARTICIPATION

No purchase is required in order to enter the Contest.

To be eligible to enter the *Running Electric Contest*, you must sign up using the Contest registration form or register during a test drive event, at <a href="https://www.roulonselectrique.ca">www.roulonselectrique.ca</a>.

By entering the Contest, you acknowledge that you have read the official Contest Rules and will comply with them.

There is a limit of one entry per person and per email address for the duration of the Contest regardless of the number of email addresses held by the contestant.

#### 2. ELIGIBILITY

The Contest is open exclusively to Canadian residents residing in the province of Quebec who are 21 years of age or over at the Contest start date.

The Contest is open to the public from August 1 to December 31, 2022.

To qualify for the *Running Electric Contest*, participants must hold a valid driver's license, minimum Class 5, at the time the rental contract is signed.

Contest eligibility is also contingent upon Sonnet Insurance agreeing to insure the driver.

Employees or representatives of the Contest organizers, their advertising or promotional agencies and of any other entity directly related to the Contest, as well as members of their immediate family, are excluded from participation. "Immediate family" includes parents, children, siblings and anyone with whom these employees or representatives reside.

### 3. PROCEDURE FOR AWARDING PRIZES

After the Contest closes, a random draw will be held among all eligible entries received during the Contest period.

Since eligibility is contingent upon Sonnet Insurance agreeing to insure the driver AND upon the driver holding a valid driver's license, the winner must provide the required information to confirm their eligibility to receive the prize.

A winner will be chosen at random to receive a 12-month lease of a Chevrolet Bolt EV from Lussier Chevrolet with insurance provided by Sonnet Insurance. The car will come with suitable Continental winter tires and a FLO charging station installed by BEQ Technology, Electric Circuit charging credits to charge the vehicle using the public network, free summer/winter tire rotation for the year courtesy of OK Tire, a Samsung telephone, wireless headphones and a Videotron cellular plan for the year.

The draw will be conducted by Équiterre at 1 p.m. on January 16, 2023, in Équiterre's Montreal offices located at 50 Sainte-Catherine Street W., Suite 340. The winner will be notified by email and telephone the week of the draw, and will be informed of the process to confirm their eligibility and of the arrangements for taking possession of their prizes.

The winner's name and photo may be published in Équiterre publications or displayed at Équiterre events.

If the winner does not respond to Équiterre's email within 10 days, Équiterre reserves the right to put the prize back in play and hold a new draw.

If it turns out that the winner is not eligible, they will be deemed to have forfeited the prize and another draw will be held.

### **4.1 DESCRIPTION OF PRIZES**

The winner will receive the following prizes:

- A full year's lease of a Chevrolet Bolt EV 2022 courtesy of Lussier Chevrolet, valued at \$12,000;
- A one-year insurance policy from Sonnet Insurance (maximum value: \$2,500);
- A FLO home electric vehicle charging station, valued at \$1,495;
- Installation of the home charging station by BEQ Technology (maximum value: \$2,500);
- \$350 in charging credits from the Electric Circuit public charging network;
- Four suitable Continental winter tires (courtesy of Continental) and summer/winter tire rotation services courtesy of OK Tire (installation and balancing included), valued at \$1,800;
- A **Videotron** cellular plan for one year, plus a Samsung S21 telephone and wireless headphones, valued at **\$2,080**.

**Total maximum value: \$22,725** 

# **4.2 PRIZE PICK-UP**

The winner will be put in contact with the Contest partners to receive each prize. Équiterre reserves the right to amend the arrangements for awarding the various prizes at the time of the draw.

### • **Sonnet Insurance** (automobile insurance)

The winner must be insurable for the prize to be awarded. They must hold a policy that covers both the damages that could be caused to others as well as damages to the leased vehicle. The policy must also include Endorsement 27 to cover damages to a loaned or leased vehicle.

The winner will be put in contact with Sonnet Insurance for assistance in choosing their insurance policy. Upon confirmation of insurability by Sonnet Insurance and of the policy purchase, the Contest organizer will pay the full policy premium for one year.

# • Lussier Chevrolet (BOLT electric vehicle)

Awarding of the prize will be contingent upon the winner qualifying for automobile insurance from Sonnet Insurance.

The winner must sign a lease contract with Lussier Chevrolet ensuring the vehicle's proper use for the period in question. Lussier Chevrolet will also provide the winner with information on the vehicle's operation and use. The car cannot be transferred to anyone other than the prize winner.

The winner will pick up the vehicle at Lussier Chevrolet Buick GMC Corvette Ltd., located at 3000 Rue Dessaulles, Saint-Hyacinthe, QC J2S 2V8 (https://www.lussierchevrolet.com/en).

Lussier Chevrolet will cover the vehicle's maintenance costs for the negotiated period but any repair costs will be the responsibility of the winner (or covered by the insurance policy).

Please note that the vehicle leased by Lussier Chevrolet must be exchanged for another equivalent Chevrolet BOLT before reaching 8,000 kilometres on the odometer. Lussier Chevrolet also reserves the right to recover the vehicle in order to exchange it for a similar model before it reaches 8,000 kilometres. If this happens, Lussier Chevrolet will cover the transportation costs of the new BOLT.

For their part, the winner must ensure that they do not exceed the aforementioned mileage of 8,000 kilometres or they will have to pay \$13,000 (i.e. the rebate available for a new electric vehicle with less than 8,000 kilometres on the odometer). Upon nearing 8,000 kilometres, the winner must contact Lussier Chevrolet for an in-store exchange or delivery of a new Chevrolet Bolt EV, if the distance justifies it.

Lastly, the winner must commit to not exceed a total of 20,000 kilometres for all the leased vehicles for the full year.

• **FLO** (home charging station)

The winner must provide Équiterre with their personal information to take possession of the home charging station.

BEQ Technology (installation of home charging station)

The charging station will be installed by a certified representative of BEQ Technology. Installation costs will be covered to a maximum of \$2,500. There is the possibility that a station cannot be installed for various technical reasons or to maintain good relations with other tenants or homeowner groups or because the costs surpass \$2,500. In such instances, the Contest organizer will not cover the cost overrun.

If the station cannot be installed or is refused, the Contest organizer will not award the cash value for the installation.

• *Electric Circuit* (charging credit)

The winner can open an account at <a href="https://lecircuitelectrique.com/en/become-a-member/">https://lecircuitelectrique.com/en/become-a-member/</a> to order their Electric Circuit charging network card, which will be sent by mail. Once the account is opened, the recharge credits will be transferred into it.

If the winner already has an Electric Circuit account, the charging credits will be transferred into it.

• **OK Tire** (winter tires)

The winner will be put in contact with OK Tire for summer and winter tire installation.

The winner will be responsible for scheduling a tire rotation appointment with an OK Tire branch for service and for complying with Quebec regulations. **Neither OK Tire nor the Contest organizers can guarantee priority access to the tire rotation service.** 

• *Videotron* (Telephone, headphones and cell plan)

The winner will be put in contact with Videotron to open an account and to receive the telephone and headphones.

The telephone and wireless headphones will remain the property of the winner after the one-year cell plan has expired, whether the plan is renewed or not.

#### 5. GENERAL CONDITIONS

- **5.1**. The prizes must be accepted as they are and cannot be exchanged or redeemed for cash. No substitution of prizes is permitted. Any unused portion of a prize awarded, for whatever reason, will be forfeited.
- **5.2**. In the event that a prize cannot be provided exactly as described in these rules, Contest organizers reserve the right to substitute a prize or item of approximately equivalent value, at their sole discretion.
- **5.3**. Any false statement by a contestant will automatically entail his or her disqualification from the Contest.
- **5.4**. Équiterre (through one of its representatives), the car dealership or the insurer could, at its sole discretion, require proof of identity or age of a contestant. Refusal to provide the proof requested will automatically lead to the contestant's disgualification.
- **5.5**. Contest organizers will not be responsible for any loss, damage or injury of any kind, including but not limited to:

- The loss, theft or damage to software or computer or telephone data, including any breach of privacy;
- Fraudulent calls;
- Inability of any person to participate in the Contest for any reason including
  mistaken addresses on mail or email, technical, computer or telephone
  malfunctions or other problems with computer online systems, services, access
  providers, computer equipment, or software; entry forms that are lost, delivered
  late, incomplete, illegible or misdirected; bugs, service outages, transmission
  failures or losses due to equipment or software, late transmissions or
  compromised data transmissions; congestion on the Internet or on any website,
  or any combination of the previous factors;
- Damage to any person's computer, including as a result of playing or downloading any material relating to the Contest;
- Loss, damage or misdirection of prizes during delivery;
- Loss, damage, defects or inability to use the prize once awarded to the winner for any reason whatsoever.
- **5.6.** You agree that in your use of social media or other platforms for this Contest, including, but not limited to, chat areas and the registration and use of social media accounts, user names or group names, you will not use obscene, libellous or slanderous language, or language that infringes upon a third party's trademark, trade name or other intellectual property right or right to privacy. Finally, a photo of you with the vehicle may be requested to be used in publications on Équiterre's social networks and/or its partners'.
- **5.7**. If it is determined by Équiterre that a contestant tampers with or abuses any aspect of this Contest, including but not limited to acting in violation of these rules, attempting to participate in the Contest more than the maximum number of times allowed, to be acting with the intent to disrupt the normal operation of this Contest, the contestant will be disqualified. Any contestant using robotic, automated, macro, programmed, third party or like methods to enter or try to enter the Contest will void any attempted entries affected by such methods and this person will be disqualified at Équiterre's sole and absolute discretion.
- **5.8**. Équiterre reserves the right to cancel or suspend this Contest at its sole discretion for any reason including but not limited to corruption of the security or proper administration of the Contest as a result of a bug, virus, tampering or other cause. Any attempt to deliberately cause damages and/or to undermine the legitimate operation of this Contest is a violation of criminal and civil laws. Should such an attempt be made, Équiterre reserves the right to seek remedies and damages to the fullest extent permitted by law, including criminal prosecution.
- **5.9**. Personal information requested at the time of registration for the test drive are collected by Équiterre and used by Équiterre to contact the winner for the purposes of the Contest.

- **5.10**. If the identity of a contestant is disputed, the authorized holder of the email address submitted at the time of entry will be deemed to be the contestant. The individual assigned to the email address for the domain associated with the submitted email address is considered the authorized account holder. A randomly drawn contestant may be required to provide proof that he or she is the authorized account holder of the email address associated with the selected entry. All entries must be submitted from a valid email account.
- **5.11**. By entering the Contest, contestants agree to abide by the Contest Rules and the decisions of Équiterre. In addition, the winner releases Équiterre from any liability for damages they may suffer as a result of taking possession of their prizes and waives any recourse or legal action against Équiterre.
- **5.12**. Entry into the Contest and the contestants' agreement to enter and abide by the rules of the *Running Electric Contest* are governed by the laws of the province of Quebec and federal laws of Canada applicable therein. By submitting their entry form, contestants agree to acknowledge the exclusive jurisdiction of the courts of Quebec.
